They Found A Place Where They Belonged

These are some of the things parents Valerie and Dan Martin said about the UDS Challenger Football and Cheerleading Program which just ended its 12th UDS season in October. The Martins were looking for a place to help their kids socialize and get involved physically. All five of the Martin kids are adopted and all have a range of disabilities.

When Valerie and Dan found out they could not have their own children several years ago, they decided to adopt and were put on a waiting list for 3 ½ years. Angela was their first adopted child. The doctors told them that Angela had several brain issues and might never lead a normal life. Though faced with Cerebral Palsy, Epileptic Aphasia and learning delays, Angela has surpassed all predicted outcomes with fierce determination. Three years later, Matthew, who has autism, came into their home. Then around four years ago, they first fostered, and then formally adopted biological siblings Yesenia, Jeremiah and Julian. All these children have severe anxiety, ADHD and trauma issues.

About the same time, the Martins got involved with Challenger Football and it has been a blessing to their family. "Our kids have finally found a place where they belong," said Valerie.

Angela, Matthew and Jeremiah play football. And Yesinia is a cheerleader. "Not only are they physically active, but we found it has been a great social connector and it helps their brains develop and helps them learn to strategize and to be members of a team," said Dan.

Even though the Challenger season ended in October, the Martins carry great memories and friendships with them to last throughout the year until the 2020 season begins next summer.

REVENUE BY PAYOR SOURCE

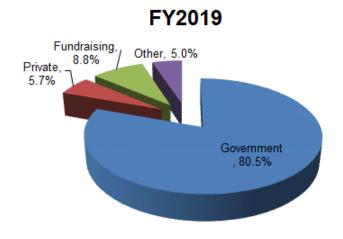

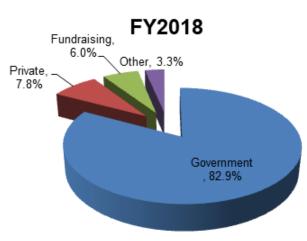
United Disabilities Services Foundation (UDSF) significantly improved the financial health of the organization in fiscal 2019, as it increased overall revenues by 11%, including net investment returns. and a healthy 8% excluding net investment returns, while expenses increased by only 2.2%. The leading service provided by UDSF was Supports Coordination, which made up 33% of the total revenue generated in FY2019. Independent Living Services made up 19% and Accessible Home Modifications made up 19%, making these the top three services provided.

We are pleased to note that UDSF generated a net excess in FY2019, with revenues exceeding expenses by \$2,142,486, equating to a very healthy 11% profit margin from overall operations; as seen in the Revenue By Source charts, this was largely attributable to the increased generosity of contributors in helping us enhance abilities and restore lives for our clients. This compares very favorably to 3% in the prior fiscal year. UDSF achieved a low debt ratio of 0.31 in FY2019, which also compared favorably to the prior year's ratio of 0.33.

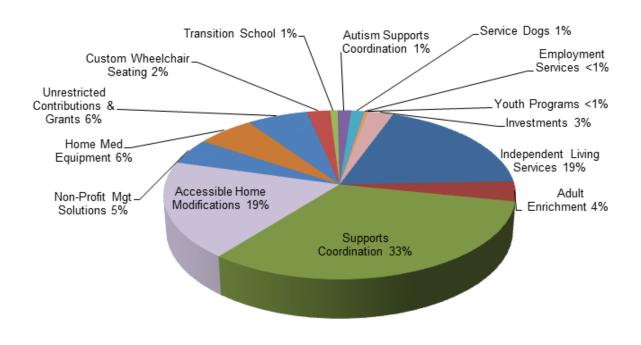
Payor Source Diversification

UDSF continues to make strides in diversifying our revenue sources. Reliance on government funding has decreased 2.4% from FY18 to FY19. In the 7-years prior to FY18, we had been experiencing only a 1% decrease in government reliance per year.

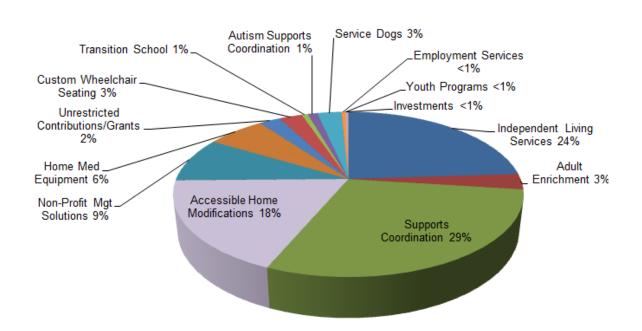




FY2019 UDSF Revenues By Program: Source of Funds

They Found The Resources They Needed

Pattie never imagined that she would be in a wheelchair, or that her husband, Roy, would be using a cane and unable to work. And yet that is exactly what happened.

Several back surgeries coupled with neuropathy and diabetes have made it impossible for Pattie to walk unassisted. Roy received a severe head injury on his job and now struggles with movement, speech and memory issues.

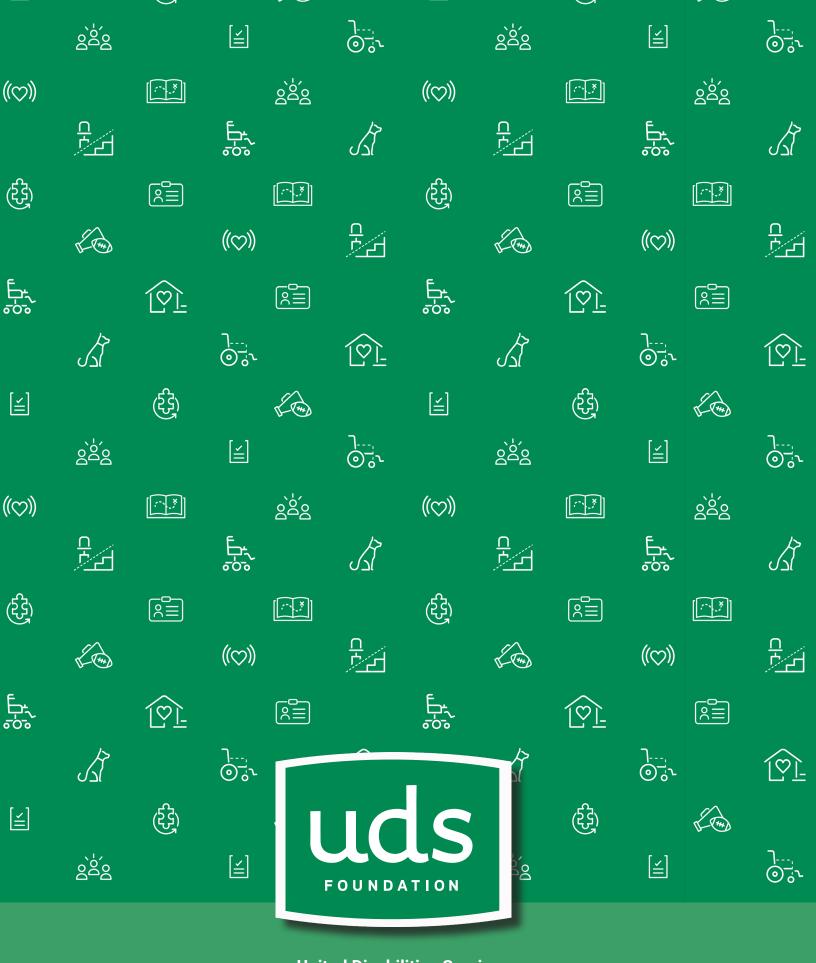
Once Pattie connected with the UDS Resource Center things changed for the better right away. The Resource Center helped her get the Medicaid waiver that helps people with disabilities stay in their homes and also connected Pattie with a UDS Care Manager, Joan.

Joan helped Pattie get a home attendant and connected her with UDS Home Modifications who installed a front door ramp and a roll-in shower. She also helped connect Pattie and Roy with Mom's Meals and they now have hot meals each day.

"Joan has been a lifesaver. I don't know what we would have done without her," said Pattie.

Since receiving UDS services, Pattie has been actively serving in the community and honoring the memory of her late son Roy Jr. by knitting headbands and hats. Roy Jr. lost his fight with heroin addiction and was often out on the street and living in his car during cold weather. Pattie works with the Mt. Joy Food Bank to distribute the headbands and hats along with first aid kits that Roy prepares to give to folks who are out on the streets with no place to live.

UDS services helped to ensure that Pattie and Roy are not only living independent lives in their own home, but that they can also help and inspire others.
