

Outcomes of Home Modification Projects July 2014 thru June 2016

United Disabilities Services Foundation conducted a recent study of OLTL participants who received a home modification via UDS Accessible Home Modifications between July 2014 and June 2016. Out of 338 clients, 138 responded to the survey (41%). The study involved a series of questions posed to participants regarding the impact of the modifications they had used for a period of one to three years. Participants responded to a direct phone call by a separate division of the Foundation with unrelated supervisory controls. Key goals and outcomes include: reducing participant and caretaker injuries, increasing participant independence and satisfaction, and assisting participants to remain independent in their homes, rather than institutions.


Nursing Home Costs
